# Shifting Baselines & New Meridians

## *Water, Resources, Landscapes, and the Transformation of the American West*

The American West is changing. As we cope with rapid population growth, we also face a changing climate that has already begun to disrupt historical weather patterns. The full brunt of these changes will not likely be known for many years. As the West changes, so too do the pressures on our land, water, and energy resources. The legal and political institutions that evolved to manage these natural resources have, for the most part, served us well. But it is far from clear that these institutions are capable of adapting as quickly and as extensively as may be necessary to serve us in the future. This conference explores these themes and considers how the transformation of the West may foreshadow fundamental changes to our legal and political institutions.
