

Thomas G. Brown Named Dean

Active alumnus and well-known Denver attorney Thomas G. Brown has been named dean of the University of Colorado School of Law. Brown's appointment, effective July 1, was confirmed on Thursday, May 31, by the University's Board of Regents. He succeeds Courtland Peterson who resigned to return to teaching and research.

Brown, 44, a native of Des Moines, Iowa, received a bachelor's degree from CU in 1956 and a law degree in 1964. His affection for and interest in the University of Colorado is quite evident as he has served as president of the Boulder Campus Alumni Association, on the boards of the Denver West and Law Alumni Associations, and as class chairman for the Law Alumni Fund.

He also is a member of the American, Colorado, and Denver Bar Associations and the First Plymouth Congregational Church and has served on the Denver District Attorney's Crime Advisory Commission.

Tom believes the law school has tremendous potential. "I would hope that my experience in the practice these past years will be an advantage in strengthening a few bridges to the bar and judiciary. Of course, I am also concerned about maintaining and building our moral and financial support."

Brown served in the U.S. Navy 1956-59. He has been a partner in the firm Welborn, Dufford, Cook and Brown since 1964.

Brown and his family reside in Littleton. His wife, Claire, is a CU alumna; his son, Stephen, will be a senior at CU; his daughter, Kristin, will be a sophomore at CU; and his daughter, Andrea, is a Littleton High School graduate who will enter CU in the fall.

Law Student Wins Nationwide Contest

Robert C. Kerr, a third-year law student has won a nationwide essay contest on environmental law sponsored by the American Bar Association. Kerr flew to Warrenton, Va., May 4 to receive a \$500 prize and a certificate at the ABA's eighth annual Conference on Environmental Law.

This year participants were asked to write on the economics of air-pollution control.

Kerr said his essay is a proposal to control air pollution through the sale of "air shares." According to Kerr's plan, companies would bid for the purchase of a finite number of air shares available in a certain area. Those possessing air shares would be able to pollute according to a limit set by the number of shares owned.

This plan would control air pollution in an area and naturally encourage companies to install pollution-control devices, Kerr said. The price of air shares would rise through the bidding process until pollution control would be economically more feasible than paying for air shares, he said.

Funds accumulated through the sale of air shares would be used for administration of the program and investment in such things as alternative transportation systems, Kerr said.

According to Kerr, his scheme is similar to systems already used for allocation of water rights in Colorado and some types of land development rights elsewhere.

Kerr previously earned a bachelor's degree in economics from Colorado State University and a master's degree in philosophy from the University of Hawaii.

Two Courses Canceled

The two proposed Continuing Legal Education courses to be taught by Professors Nort Steuben and Ken Lidstone and by Ted Fiflis and Harold Bloomenthal have been canceled indefinitely. These two courses, "Taxation of Partners and Partnerships" and "Securities Regulation and Federal Courts," were originally scheduled to be offered July 9-13, 1979. Unforeseen circumstances caused a delay in informing potential registrants. It was felt that it would be advisable to begin anew. There is a possibility these courses may be offered at a later time.

To avoid confusion, it must be stated that the Estate Planning Institute with Professor Bill Bowe will still be held as scheduled. As a matter of fact that course carries 15 units of CLE and has been filled for some time now.

Carlos Lucero Receives Honorary Coif

Alamosa attorney Carlos F. Lucero received honorary membership in the Order of the Coif, the top scholastic society for the legal profession, Friday, May 25, from the University of Colorado School of Law.

The presentation was made during the law school commencement program at Fleming Law Building. His wife, Dorothy, accepted for Lucero who was in the midst of litigation on a water rights case.

The law school annually confers Order of the Coif membership upon a distinguished Colorado attorney in recognition of his achievements in the legal field.

Lucero, 38, is the youngest person ever to serve as president of the Colorado Bar Association. A native of the San Luis Valley, he is a partner in the Alamosa firm of Pound and Lucero.

He holds a bachelor's degree from Adams State College where he served as student body president. His law degree is from George Washington University, Washington, D.C. While in Washington, Lucero was a

While in Washington, Lucero was a staff member of former Colorado Senator John A. Carroll and a staff assistant to a U.S. Senate judiciary subcommittee.

He was admitted to practice in Colorado in 1964 and worked a year as a law clerk for U.S. Judge William E. Doyle before returning to the San Luis Valley to enter private practice.

He is a past president of the San Luis Valley Bar Association and was a director on the founding board of Colorado Rural Legal Services, established to assist the indigent in legal matters. In 1969 Lucero was selected by the state Jaycees as one of the outstanding young men of Colorado.

Don Sears Receives Humanitarian Award

The graduating class of 1979 awarded the Faculty Humanitarian Award to Professor Don Sears at commencement. According to the third-year class, the award is "intended to honor the faculty member who best exemplifies a lawyer's ability to achieve professional excellence without sacrificing personal sensibilities." Specifically, recognition is given to the professor who demonstrates self-assurance and self-respect; challenges students by personal example to develop professional and personal potential fully; evinces his/her respect

Riesenfeld, Guest Law Professor

Stefan A. Riesenfeld, principal draftsman of the recent U.S.-Panama treaties, will be the Charles Inglis Thomson guest professor this summer at the University of Colorado School of Law, teaching public international law. Riesenfeld, a professor at the University of California at Berkeley, was on leave in 1977-78 in the office of the legal adviser of the U.S. Department of State when he worked on the treaties. Riesenfeld's areas of interest include commercial law, bankruptcy, social legislation and international law

The Thomson professorship was established at the law school under a bequest by Olivia Thomson in memory of her husband, a noted attorney and iudae
