SEC. 3. *And be it further enacted*, That upon the written application or oath of any person or persons to a justice of the peace in the county where the offense is charged to have been committed, stating the nature of the offense, it shall be the duty of said justice, forthwith to issue his warrant, directed to the sheriff or any constable of the county, commanding him to immediately arrest said person or persons, and bring them before him to be dealt with according to law.

Duty of Justice of the Peace in such cases.

SEC. 4. *And be it further enacted*, That all stock found grazing, herded, or feeding in violation of this act, shall be held liable for the payment of the fine and costs imposed.

Stock held liable for fine and costs.

Approved August 15th, 1862.

## AN ACT

TO REPEAL ALL LAWS IN RELATION TO THE INTRODUCTION OF STOCK IN CONEJOS COUNTY, FOR THE PURPOSE OF GRAZING.

*Be it enacted by the Council and House of Representatives of Colorado Territory:*

SECTION 1. That all laws preventing the importation of stock in the county of Conejos, by non-residents, for grazing purposes, be, and the same are hereby repealed.

Repealing law concerning importation of stock, etc.

SEC. 2. This act shall be in force from and after its passage.

Approved August 15th, 1862.

## AN ACT

AMENDATORY OF "AN [ACT] CONCERNING WILLS, EXECUTORS AND ADMINISTRATORS."

*Be it enacted by the Council and House of Representatives of Colorado Territory:*

SECTION 1. That wherever in sections 94, 95, 97 and 98, the words "District Court" occurs, that the same be amended, by striking out the said words "District Court," and inserting the words "Probate Court."

Powers of Probate Courts extended.

Approved August 15th, 1862.
