An act for the relief of Adeline McFarland, of Boulder County.

Be it enacted by the Council and House of Representatives of Colorado Territory:

Section 1. That the sum of three hundred dollars be and the same is hereby appropriated for the support, maintenance and education of Adeline McFarland, an orphan child of the late Robert McFarland, who fell in the service of his country at Sand Creek, November 29, 1864.

SEC. 2. That the Hon. Henry L. Pearson, of the county of Boulder, is hereby authorized to receive the money specified in section one of this act, and judiciously apply the same to the

use and benefit of the said Adeline McFarland.

SEC. 3. That the auditor of the territory is hereby authorized to draw a warrant on the territorial treasurer for the sum of three hundred dollars, to be paid out of any funds in his hands not otherwise appropriated, for the purpose specified in section one of this act.

Sec. 4. This act shall take effect and be in force from and after its passage.

Be it enacted by the Council and House of Representatives of Colorado Territory:

Section 1. That the county commissioners of the county of Summit have power, and are hereby authorized to appropriate the military fund raised in the said Summit county in the year 1867, and that which may be raised in the year 1868, by virtue of an act entitled An act to encourage the formation of volunteer companies, to the use of said county of Summit, in the construction of a bridge or bridges across Blue river, at such point or points on said Blue river, between the town of Breckenridge and what is known as the Gold Run crossing, as the said commissioners may at their regular meeting direct.

SEC. 2. All acts, sections, and parts of acts inconsistent with

the provisions of this act, are hereby repealed.

Sec. 3. This act shall take effect and be in force from and after its passage.
