An act to authorize the County Commissioners of the Counties of Lake, Boulder, Larimer and Weld to appropriate to the construction of Roads and Bridges the Military Fund raised by virtue of an act entitled An act to encourage the formation and equipment of Volunteer Companies, approved February 10, 1865.

*Be it enacted by the Council and House of Representatives of Colorado Territory:*

SECTION 1. That the county commissioners of the counties of Lake, Boulder, Larimer and Weld have power, and are hereby authorized to appropriate the military fund raised in the said counties by virtue of an act entitled An act to encourage the formation of volunteer companies, to the use of said counties of Lake, Boulder, Larimer and Weld in the construction of roads and bridges, as the said commissioners may at regular meetings direct; but in no case shall the said fund be appropriated to bridges now under contract.

SEC. 2. That the county commissioners shall appropriate so much of the said military fund to each of the road districts as the said district has paid into the said military fund; and to be expended as is now required by road supervisors.

SEC. 3. This act to take effect and be in force from and after its passage.

Approved January 10, A. D. 1868.

An act to extend the Corporate Limits of the City of Denver.

*Be it enacted by the Council and House of Representatives of Colorado Territory:*

SECTION 1. The corporate limits of the city of Denver, in the county of Arapahoe, are hereby extended so as to include within said city the north-east quarter of section numbered three, in township numbered four south, range sixty-eight west; also the west half of section twenty-six, the west half of the north-east quarter, and the west half of the south-east quarter of said section twenty-six; also that part of sections twenty-seven and twenty-eight east and south of the South Platte river and following the main channel of said river to the north line of the congressional grant; also all the west half of section thirty-five, and the west half of the north-east quarter, and the west half of the south-east quarter of said section thirty-five; also the east half of section thirty-four, all in township numbered three south, range sixty-eight west, according to the survey of the lands of this territory by the United States.
