An act to provide for the payment of the Assistant Enrolling, and the Assistant Engrossing Clerk, employed by the Council and Rouse of Representatives at their seventh Session.

Be it enacted by the Council and House of Representatives of Colorado Territory:

SEC. 1. That the assistant enrolling clerk shall receive the sum of ten dollars per day, and the assistant engrossing clerk shall receive the sum of ten dollars per day.

SEC. 2. The certificate of the speaker of the house of representatives, countersigned by the chief clerk of the house of representatives, or the certificate of the president of the council countersigned by the secretary of the council, shall be sufficient authority for the auditor of the territory to draw warrants for the several amounts so certified to, upon the territorial treasurer, which shall be paid out of any funds in the territorial treasury, not otherwise appropriated; and the several officers, respectively, shall be paid for the time they, respectively, were actually in the service of the council and house of representatives; and the certificate aforesaid, shall specify the number of days for which each person receiving the same is entitled to pay.

SEC. 3. This act to take effect and be in force from and after its passage.

Approved January 10, A. D. 1868.

An act to provide for the relief of Francis Gallup and Andrew J. Williams.

Be it enacted by the Council and House of Representatives of Colorado Territory:

SECTION 1. That there is hereby appropriated out of any moneys in the treasury not otherwise appropriated, eight hundred and thirty seven dollars and seventy-two cents, to Francis Gallup, in payment of military equipments furnished by him to the militia of the territory, called into service under the proclamation of Governor Hunt, dated the 8th day of June, A. D. 1867.

SEC. 2. That the sum of six hundred and twenty five dollars is hereby appropriated out of any moneys in the treasury not otherwise appropriated, to Andrew J. Williams, in payment of beef furnished by him to the militia of the territory, called out under the proclamation of Governor Hunt, dated the 8th day of June, A. D. 1867.
