portion of said appropriation shall be expended, except so much as may have been necessary to defray the expense of such examination and survey.

To be a Sec. 3. Such viaduct and bridge when completed, public highway shall be a public highway, free to the use of all pedestrians, equestrians, bicycles, wagons, carriages and other vehicles.

City of Denver to keep in repair, Sec. 4. When constructed, it shall be the duty of the city of Denver to keep such viaduct and bridge in repair at its own expense.

Auditor to draw warrant.

Sec. 5. Upon the commencement of construction of said viaduct or bridge, as herein specified, and that fact being certified to by the Governor, the mayor of Denver and the engineer of the board of public works of the city of Denver, the Auditor of State is hereby directed to draw warrants for the amount appropriated by section 1 of this act in favor of the treasurer of the city of Denver.

### AN ACT

APPROPRIATING THE SUM OF TWENTY THOUSAND AND SEVENTY-NINE DOLLARS AND NINETY CENTS (\$20,079.90), OR SO MUCH THEREOF AS MAY BE NECESSARY TO PAY THE PRINCIPAL AND INTEREST OF CERTAIN WARRANTS, ISSUED IN PAYMENT OF SERVICES AND SUPPLIES RENDERED TO THE STATE AND PURCHASED BY THE AMERICAN SAVINGS BANK OF NEW YORK CITY, NEW YORK, AT A PREMIUM ABOVE THEIR PAR VALUE.

Be it Enacted by the General Assembly of the State of Colorado:

Appropriation.

Section 1. That there is hereby appropriated, the sum of twenty thousand and seventy-nine dollars and

ninety cents (\$20,079.90), or so much thereof as may be necessary, to make payment in full of the following outstanding State warrants, to wit:

Section 2. Upon presentation and surrender of said Treasurer pay outstanding warrants, the Treasurer of the State is here on presentation by authorized and directed to pay the holders and owners of said warrants, for the full amount of said warrants, both principal and interest, respectively, from the date of issue. Such payments, however, not to exceed in all, the sum of twenty-thousand and seventy-nine dollars and ninety cents (\$20,079.90), and said warrants shall be paid by the State Treasurer upon presentation thereof

to him out of moneys in the State treasury, hereby and not otherwise appropriated.

Emergency.

Section 3. In the opinion of the General Assembly an emergency exists; therefore, this act shall take effect and be enforced from and after its passage.

## AN ACT

MAKING AN APPROPRIATION TO PAY THE CLAIM OF THE WESTERN FEDERATION OF MINERS AGAINST THE STATE OF COLORADO, FOR THE APPROPRIATION AND DESTRUCTION FOR MILITARY PURPOSES, BY THE STATE OF COLORADO, OF PROPERTY IN THE COUNTY OF TELLER, DURING THE YEAR 1904, AND PROVIDING FOR THE AUDITING OF SAID CLAIM.

Be it Enacted by the General Assembly of the State of Colorado:

Appropriation.

Purposes.

Section 1. That the sum of fifty-five thousand, five hundred and twenty dollars (\$55,520.00) be, and the same is, hereby appropriated out of any funds in the state treasury, not otherwise appropriated, to pay the claim of the Western Federation of Miners against the State of Colorado, for the appropriation and destruction of, and damage done, in 1904, to the stocks of merchandise and general supplies owned by said The Western Federation of Miners, in the County of Teller; the said appropriation, damage or destruction, having been done and committed by the State of Colorado for mili-
