**CHANGING THE NAME OF THE "COLORADO STATE COLLEGE OF EDUCATION AT GREELEY" TO THE "COLORADO STATE COLLEGE" AND CHANGING THE NAME OF "THE TRUSTEES OF THE STATE NORMAL SCHOOLS" TO THE "TRUSTEES OF THE STATE COLLEGES IN COLORADO."**

*Be It Enacted by the General Assembly of the State of Colorado:*

**Section 1.—Name of college changed—**The state school at Greeley, referred to under the name and title of the "Colorado State College of Education at Greeley" by article 6, chapter 124, Colorado Revised Statutes 1953, and amendments thereto, shall hereafter be designated under the name and title of the "Colorado State College"; **provided, however,** that the legal effect of any statute heretofore designating such institution by any other name, or property rights heretofore acquired and obligations heretofore incurred under any other name, shall not be impaired hereby.

**Section 2.—Name of trustees changed—**The board of trustees which controls certain state colleges, designated by the name of "the trustees of the state normal schools" in section 124-5-1, shall hereafter be designated under the name of the "Trustees of the State Colleges in Colorado"; **provided, however,** that the legal effect of any statute heretofore designating such board of trustees by any other name, or property rights heretofore acquired and obligations heretofore incurred under any other name, shall not be impaired hereby.

Section 3.—**Safety Clause**—The General Assembly hereby finds, determines and declares that this act is necessary for the immediate preservation of the public peace, health and safety.

Section 4.—**Effective date**—This act shall be in force and effect from and after October 1, 1957.
