APPROPRIATION

GENERAL—SHORT

(H. B. No. 235, by Mr. Wilson, El Paso)

AN ACT

AN ACT TO PROVIDE FOR THE PAYMENT OF A PART OF THE ORDINARY EXPENSES OF THE EXECUTIVE, LEGISLATIVE AND JUDICIAL DEPARTMENTS OF THE STATE OF COLORADO FOR THE MONTHS OF DECEMBER, 1920, JANUARY, FEBRUARY AND MARCH, 1921.

Be It Enacted by the General Assembly of the State of Colorado:

Section 1. That the following designated sums, or so much thereof as may be necessary, are hereby appropriated out of any moneys in the State Treasury, not otherwise appropriated, for the payment of the expenses of the Executive, Legislative and Judicial Departments of the State of Colorado for the months of December, 1920, January, February and March, 1921, to-wit:
