## CHAPTER 70

## TAXATION I—GENERAL PROPERTY TAX

## COLORADO TAX COMMISSION

## AN ACT

AUTHORIZING THE STATE TAX COMMISSION TO ESTABLISH A SCHOOL FOR COUNTY ASSESSORS AND CERTAIN OTHERS.

*Be It Enacted by the General Assembly of the State of Colorado:*

Section 1. 137-6-12, Colorado Revised Statutes 1953, is hereby amended by adding thereto a new subsection to read:

137-6-12. Duties, power and authority.—(11) (a) For the purpose of promoting equalization of assessed valuations of properties within the state of Colorado and to the end that all assessments of property shall be made relatively just and uniform, the commission may, each year, provide for a school, or schools, for county assessors, deputy county assessors, or both, and for such employees of the commission as the commission may request to attend. Such school, or schools, shall be conducted for periods not to exceed a total of fifteen days. The matters and subjects discussed shall be such as in the opinion of the commission and the county assessors will be most likely to accomplish the purposes hereinabove set forth.

(b) All reasonable and necessary expenses for travel, lodging and subsistence of the assessors and deputies shall be paid by the respective counties. The cost of the operation of such school, or schools, including the cost of instruction, shall be paid by the commission.

Section 2. **Safety clause.**—The General Assembly hereby finds, determines, and declares that this act is necessary for the immediate preservation of the public peace, health, and safety.

Approved: March 18, 1960.
