MOTION OF CATLIN CANAL COMPANY AND HIGH LINE CANAL COMPANY TO APPEAR AS AMICI

Attorney for Amici, CATLIN CANAL COMPANY and HIGH LINE CANAL COMPANY CATLIN CANAL COMPANY and HIGH LINE CANAL COMPANY, irrigating ditch companies located in the State of Colorado, by their attorney, REXFORD L. MITCHELL, respectfully move the court pursuant to Rule 29 of the Colorado Appellate Rules for leave to appear as Amici and to file a brief with this court in the above entitled case.
