## GAME AND FISH COMMISSION

(Senate Bill No. 40. By Senators Locke, Shoemaker, and Brown; also Representatives Kane, Braden, Vanderhoof, Compton, McCormick, Clark, and Stalker.)

## AN ACT

AMENDING 62-2-22 AND REPEALING 62-2-23, COLORADO REVISED STATUTES 1953, CONCERNING THE CONSERVATION MAGAZINE PUBLISHED BY THE GAME AND FISH DEPARTMENT.

*Be It Enacted by the General Assembly of the State of Colorado:*

Section 1. 62-2-22, Colorado Revised Statutes 1953, is hereby amended to read:

62-2-22.—**Conservation magazine — revenue.**—The game and fish department is hereby authorized to distribute a conservation magazine on a paid subscription basis, and it is further authorized to deposit the revenue derived therefrom in a special fund to be used by the state game and fish commission for the compilation, publication and distribution of the aforesaid publication AND THE REVENUES DERIVED THEREFROM SHALL BE DEPOSITED IN THE STATE TREASURY AND CREDITED TO THE GAME CASH FUND. Any funds necessary for the original publication over and above the amount received from subscription revenue shall be funds so budgeted FUNDS NECESSARY FOR THE PUBLICATION OF SAID MAGAZINE AND SALES FEES PROVIDED FOR IN THIS SECTION SHALL BE APPROPRIATED in the appropriation from the game cash fund. This SAID conservation magazine may be sold by the commission or by an individual designated by the commission. The commission may pay to those individuals who sell any conservation magazine published under authority of this section an amount of ten cents for each annual subscription fee

paid by the subscriber. This SAID fee shall be for the personal compensation of such individual for filing the subscription application, issuing the receipt therefor, the mailing of such application and receipt to the commission, and the furnishing of a bond to secure all moneys collected, due, and payable to the commission.

Section 2.—**Repealing clause.**—62-2-23, Colorado Revised Statutes 1953, is hereby repealed, and on the effective date of this act, any unencumbered moneys remaining in the special fund referred to in said section, shall revert to the game cash fund.

Section 3.—**Effective date.**—This act shall take effect on July 1, 1963.

Section 4.—**Safety clause.**—The general assembly hereby finds, determines, and declares that this act is necessary for the immediate preservation of the public peace, health, and safety.

Approved: March 13, 1963.
