## NEWLAN CREEK GAME REFUGE

(S. B. No. 131, by Senator Durfee and Messrs. Evans and Sylvester)

## AN ACT

AMENDING SECTION 1 OF AN ACT ENTITLED, "AN ACT TO CREATE AND ESTABLISH THE NEWLAN CREEK STATE GAME REFUGE, AND TO REGULATE AND PROHIBIT THE HUNTING OR KILLING OF GAME THEREIN, AND TO PROVIDE CERTAIN PENALTIES," APPROVED MARCH 18, 1925, AND BEING CHAPTER 105 OF THE SESSION LAWS OF COLORADO 1925.

*Be It Enacted by the General Assembly of the State of Colorado:*

Section 1: That Section 1 of Chapter 105 of the Session Laws of 1925 be and the same is hereby amended to read as follows:

Section 1. For the better protection of birds and animals, and the establishment of breeding places therefor the following area within the State of Colorado is hereby set aside, designated and established, as a State Game Preserve: All of that portion of the State of Colorado embraced within the following described area, which area shall constitute and be known as the Newlan Creek State Game Preserve:

**Boundaries**

All of Sections 10, 11, 12, 13, 14, 15, 22, 23, 24, 25, 26, 27, 34, 35 and 36 in Township 20 South Range 71 West of the 6th P. M. Sections 7, 8, 9, 16, 17, 18, 19, 20, 21, 22, 27, 28, 29, 30, 31, 32, 33, 34, 35 and 36 in Township 20 South Range 70 West of the 6th P. M. Sections 1, 2, 3, 4, 5, 6, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 21, 22, 23, 24, 25, 26, 27, 28, NE  $\frac{1}{4}$  of 33, 34, 35 and 36 in Township 21, South, Range 70 West of the 6th P. M. Sections 6, 7, 16, 17, 18, 19, 20, 21, 28, 29, 30, 31, 32 and 33 in Township 21, S. Range 69 West of the 6th P. M. PROVIDED, That nothing in this Act shall be construed to prevent the pasturing of domestic animals upon said game preserve or the right of ingress or egress of such animals thereon.

**Safety clause**

Section 2. The General Assembly hereby finds, determines and declares that this act is necessary for the immediate preservation of the public peace, health and safety.

**Emergency**

Section 3. In the opinion of the General Assembly an emergency exists; therefore, this Act shall take effect and be in force from and after its passage.
