CHAPTER 107

GAME REFUGE

WILLIAMS FORK GAME REFUGE

(S. B. No. 255, by Senator Flebbe and Representative Murphy)

AN ACT

CHANGING AND DETERMINING THE BOUNDARIES OF THE WILLIAMS FORK GAME REFUGE.

Be It Enacted by the General Assembly of the State of Colorado:

Section 1. PROPOSED REVISED BOUNDARY OF WILLIAMS FORK GAME REFUGE: Beginning at the point where the Range line between Township 1 North, Ranges 77 and 78 West crosses the Cottonwood Pass Road, thence in a southeasterly direction along the said Cottonwood Pass Road to the intersection of the now existing boundary of the Arapahoe National Forest, thence following said Forest boundary in a south and easterly direction to its intersection with Hull Creek, thence along the east bank of Hull Creek to the intersection with Keyser Creek, thence along the southern bank of Keyser Creek to its intersection with the Williams Fork River, thence along the west bank of the Williams Fork River to its intersection with the

County Road in Section 28, Township 1 South, Range

78, West, thence along said County road to its inter-

section with the bottom of Brinker Gulch, thence easterly along the bottom of Brinker Gulch to the

Revised Boundary of Williams Fork Gams Refuge intersection with the Arapahoe National Forest boundary, thence along said boundary to its intersection with Little Muddy Creek, thence down the south bank of Little Muddy Creek to its intersection with the Colorado River, thence down the south bank of the Colorado River to its intersection of Corral Creek, thence northerly along the west bank of Corral Creek to its intersection with the range line between Ranges 78 and 79 West, thence north along said range line to the divide between Corral Creek and the tributaries of the Troublesome Creek, thence along the Divide between Corral and Troublesome Creek, and Corral and Willow Creeks, and Kinney and Cabin Creek to the head of the East Fork of Kinney Creek, thence along Kinney Creek to its intersection with the State Highway No. 40, thence westerly along said Highway to its intersection with the Cottonwood Pass Road, thence easterly along said road to the point of beginning.
