CHAPTER 115

IRRIGATION

OFFICE OF DIVISION ENGINEER IRRIGATION DIVISION NO. 1 ABOLISHED

(H. B. No. 456, by Representative Swediund and Senator King)

AN ACT

ABOLISHING THE OFFICE OF IRRIGATION DIVISION EN GINEER OF IRRIGATION DIVISION NO. 1, TRANSFERRING THE DUTIES, POWERS AND FUNCTIONS OF THAT OFFICE TO THE STATE ENGINEER, PROVIDING FUNDS FOR THE USE OF THE STATE ENGINEER IN EXERCISING SUCH DUTIES, POWERS AND FUNCTIONS, AND REPEALING ALL ACTS AND PARTS OF ACTS IN CONFLICT HEREWITH.

Be It Enacted by the General Assembly of the State of Colorado:

Office Division Engineer District No. 1 Abolished Section 1. The office of Irrigation Division Engineer of Irrigation Division No. 1 is hereby abolished and the services of the Irrigation Division Engineer of said Irrigation Division are dispensed with, and the duties, powers and functions of that office are hereby transferred to the State Engineer.

Repealing Clause

Section 2. All Acts or parts of Acts in conflict herewith are hereby repealed.

Safety Clause

Section 3. It is hereby declared that this Act is necessary for the immediate preservation of the public peace, health and safety.
