## CHAPTER 46

## AGRICULTURE I — GENERAL PROVISIONS

## STATE DEPARTMENT OF AGRICULTURE

(House Bill No. 342. By Representatives McNeill, Lamb, Burns, Kane, Saunders, Lewis, Lebsack, Stalker, and Autry.)

## AN ACT

AMENDING 6-1-10 (1), COLORADO REVISED STATUTES 1953, AS AMENDED, TO PROVIDE FOR THE DISPOSITION OF FUNDS COLLECTED BY THE DEPARTMENT OF AGRICULTURE FOR THE INSPECTION OF FRUITS AND VEGETABLES.

*Be It Enacted by the General Assembly of the State of Colorado:*

Section 1. 6-1-10 (1), Colorado Revised Statutes 1953 (1960 Perm. Supp.), is hereby amended to read:

6-1-10.—**Disposition of revenues.**—(1) (a) The monies accruing to the hail insurance fund shall be deposited as provided in section 6-4-12. Subject to the provisions of section 3-7-3, CRS 1953, the license fees accruing to the weights and measures fund shall be deposited as provided in section 151-1-23, CRS 1953, AS AMENDED. All fees paid for the inspection of fruits and vegetables shall be deposited with the state treasurer and by him credited as follows: ~~five per cent to the state general fund and ninety-five per cent to the state department of agriculture fund, hereby created; all other fees and monies collected by and for the department or any of its subdivisions shall be deposited with the state treasurer and by him credited as follows: Ten per cent to the state general fund and ninety per cent to the state department of agriculture fund.~~ All revenue derived from fees imposed for specific purposes shall be used by the department exclusively for such purposes, excluding the amount credited to the general fund. At the end of each fiscal year, the unexpended balance of the amounts collected for each specific pur-

pose shall be retained in the contributing account for use in ensuing fiscal years.

(b) The department of agriculture fund shall be maintained by appropriate accounting records, in such manner as to indicate all receipts and expenditures made with respect to each service administered by the department.

Section 2.—**Safety clause.**—The general assembly hereby finds, determines, and declares that this act is necessary for the immediate preservation of the public peace, health, and safety.

Approved: May 3, 1963.
