COMPENSATION OF JOINT BUDGET COMMITTEE

(Senate Bill No. 25. By Senators Brown, Locke, McCulloch, and Porter; also Representatives Kelley, Atkinson, Autry, Ohlson, Clark, Stalker, Mackie, Dines, Wyatt, Rubin, Moore, and Pellet.)

AN ACT

AMENDING 63-2-7 (4) (d), COLORADO REVISED STATUTES 1953, AS AMENDED, INCREASING THE COMPENSATION OF MEMBERS OF THE JOINT BUDGET COMMITTEE.

Be It Enacted by the General Assembly of the State of Colorado:

Section 1. 63-2-7 (4) (d), Colorado Revised Statutes 1953, as amended by section 2 of chapter 62, Session Laws of Colorado 1962, is hereby amended to read:

63-2-7.—**Compensation of members.**—(4) (d) The further sum of twenty dollars per day, not to exceed six hundred dollars in any calendar year, except for members ~~for~~ OF the joint budget committee for whom the maximum shall be ~~one~~ TWO thousand dollars per year, for necessary attendance while the general assembly is not in session, at meetings of the legislative council, joint budget committee, interim committees authorized by joint resolution of the two houses or by law, or committees established by the legislative council; together with all actual and necessary traveling expenses to be paid after the same have been incurred and audited. Mileage rates and per diem allowances shall not exceed those authorized for the executive departments unless special circumstances are shown to the satisfaction of the state controller. The general assembly may provide by joint resolution for a suspension of its compensation or any portion thereof during a period of adjournment to a day certain.

Capital letters indicate new material added to existing statutes; dashes through words indicate deletions from existing statutes and such material not part of act.

Section 2.—**Safety clause.**—The general assembly hereby finds, determines, and declares that this act is necessary for the immediate preservation of the public peace, health, and safety.
