COMPARATIVE TABLE COLORADO REVISED STATUTES PRE-SUPPLEMENT TABULATION (For advance information only)

Changes made by Second Regular Session of the Forty-fourth General Assembly (1964) in Colorado Revised Statutes 1953, the 1960 Permanent Cumulative Supplement (Volume 8) to Colorado Revised Statutes 1953, the 1961 Supplement to Colorado Revised Statutes 1953, and the enactments of the 1962 Regular Session and 1963 Regular Session of the General Assembly.

This tabulation for immediate and interim use shows changes in Colorado Revised Statutes 1953, the 1960 permanent cumulative supplement (Volume 8), the 1961 supplement, and the 1962 and 1963 enactments of the General Assembly, made by enactments of the second regular session (1964) of the General Assembly.

N.B. The 1962-1963 enactments will appear as edited, revised, and re-enacted by the General Assembly, in the new edition of Colorado Revised Statutes 1963, and not in pocket parts. The 1964 enactments of the General Assembly as edited, revised and re-enacted will appear in the next biennial supplement. This tabulation contains the statutory changes by CRS 53 section numbers and the corresponding proposed C.R.S. 1963 section numbers. The C.R.S. 1963 section numbers are proposed only and are subject to change and are contained herein for convenience only.
