(House Bill No. 1299. By Representatives Foster and Lamb.)

## AN ACT

AMENDING 129-2-10 (1) (a), COLORADO REVISED STATUTES 1963, REGARDING DURATION OF HORSE RACE MEETS.

*Be It Enacted by the General Assembly of the State of Colorado:*

Section 1. 129-2-10 (1) (a), Colorado Revised Statutes 1963, is hereby amended to read:

129-2-10.—Duration of meets.—(1) (a) It shall be unlawful to conduct any racing meet at which wagering is permitted except under the provisions of this article. The duration of any horse race meet shall not exceed thirty RACING days, excluding Sundays. A RACE DAY SHALL BE ANY PERIOD OF TWENTY-FOUR HOURS BEGINNING AT MIDNIGHT AND INCLUDED IN THE PERIOD OF A RACE MEETING AND UPON WHICH RACING IS TO BE HELD. DARK DAYS WITHIN A MEETING SHALL NOT BE CONSTRUED TO BE RACING DAYS. Subject to the provisions of this article, the number and kind of race meets to be held in any one county in any one year shall be determined by the commission; provided, that not more than two licensed horse race meets shall be held on any one track in any one year. Not more than two race meets for animals other than horses shall be licensed in any county in any one year, and no such race meet for animals other than horses by any licensee shall be held for a duration longer than thirty RACING days, EXCLUDING SUNDAYS. RACING MEETS CONDUCTED BY ANY STATE, COUNTY, OR OTHER FAIR COMMISSION OR ASSOCIATION

*Capital letters indicate new material added to existing statutes; dashes through words indicate deletions from existing statutes and such material not part of act.*

SHALL BE HELD ON SUCH DATES, AND FOR SUCH PERIODS OF TIME, NOT TO EXCEED SIX DAYS, AS MAY BE SET BY THE COMMISSION. No licensed race meet conducted under the provisions of this article shall be conducted on any Sunday.

**Section 2.—Safety clause.**—The general assembly hereby finds, determines, and declares that this act is necessary for the immediate preservation of the public peace, health, and safety.

Approved: April 29, 1965.
