GAME, FISH, AND PARKS COMMISSION

(Senate Bill No. 216, By Senator Lamm; also Representatives Jackson, Foster, Massari, and Baer.)

### AN ACT

AMENDING 62-2-16 (7), COLORADO REVISED STATUTES 1963, CONCERNING SEASONS AND BAG LIMITS.

Be It Enacted by the General Assembly of the State of Colorado:

Section 1. 62-2-16 (7), Colorado Revised Statutes 1963, is hereby amended to read:

62-2-16.--Seasons and bag limits.-(7) The open season for all migratory game birds for the state of Colorado shall be the same as that now fixed, or as hereafter may be fixed under the administrative provisions of "the migratory bird treaty act" of congress, fitle 16, chapter 7, U.S.C.A. Any change made by the secretary of agriculture UNITED STATES DEPARTMENT OF THE IN-TERIOR, FISH AND WILDLIFE SERVICE, or any new rulings made by him THE SECRETARY OF THE INTERIOR under said act, which would be applicable to the state of Colorado, shall be in effect in the state of Colorado, and shall be enforced by the commission. The term "migratory birds" shall include such birds as are defined under the administrative provisions of said "the migratory bird treaty act" and regulations now in force or hereafter adopted pursuant to section 3 of said act. title 16, chapter 7, section 704, U.S.C.A. It is the intention of this section to make the laws of this state conform to the provisions of "the migratory bird treaty act". and the regulations adopted pursuant thereto, and the

commission shall have such power and authority as may be necessary to make this intent effective by regulations.

Section 2.—Safety clause.—The general assembly hereby finds, determines, and declares that this act is necessary for the immediate preservation of the public peace, health, and safety.
