CHAPTER 224

AUTOMOBILES AND OTHER MOTOR VEHICLES

ADDITIONAL REGISTRATION FEE

(Senate Bill No. 91. By Senators Hewett, Oliver, and Williams; also Representatives Gossard and Mackie.)

A N A C T

AMENDING 13-3-30, COLORADO REVISED STATUTES 1963, AS AMENDED, CONCERNING THE REGISTRATION FEE OF ONE DOLLAR FIFTY CENTS FOR MOTOR VEHICLES, TRAILERS, AND SEMITRAILERS.

Be it enacted by the General Assembly of the State of Colorado:

Section 1. 13-3-30, Colorado Revised Statutes 1963, as amended by section 1 of chapter 3, Session Laws of Colorado 1966, is REPEALED AND RE-ENACTED, WITH AMENDMENTS, to read:

13-3-30. Additional annual registration fee for certain vehicles.—

(1) Every owner of a motor vehicle, trailer, or semitrailer which is primarily designed to be operated or drawn upon any highway of this state, except such vehicles as are specifically exempted from payment of any registration fee by the provisions of this article, shall, within the registration period prescribed by law, or within ten days from the date of purchase of any such vehicle, pay to the authorized agent in the county wherein such vehicle is to be registered, or to the department, as the case may be, an annual registration fee of one dollar and fifty cents, which annual fee shall be in addition to the annual registration fee now prescribed by law for such vehicle.

(2) The additional registration fee provided for in this section shall not be transmitted to the department, but the aggregate amount of all such fees paid over by the authorized agent to the county treasurer shall be retained by the treasurer and allocated by him to the county and to the cities and incorporated towns located within the boundaries of the county on the basis of the record of rural and urban registrations kept by the authorized agent to indicate the place of residence of each vehicle owner paying registration fees.

(3) Every owner of any vehicle specified in subsection (1) of this section who is required to pay an annual registration fee for such vehicle to the department shall also pay the additional annual registration fee provided for in this section to the department, and the department shall transmit such additional fee to the proper county treasurer, as indicated by the place of residence of such owner, and such county treasurer shall allocate such fee in the manner prescribed in subsection (2) of this section.

(4) All amounts allocated to the county shall be credited to the county road and bridge fund, and all amounts allocated to a city or incorporated town shall be credited to an appropriate fund and expended by such city or incorporated town only for the construction and maintenance of highways, roads and streets located within its boundaries.

(5) The additional registration fee hereby imposed shall be applicable during the calendar years 1968 and 1969 only.

Section 2. Safety clause.—The general assembly hereby finds, determines, and declares that this act is necessary for the immediate preservation of the public peace, health, and safety.
