#### STATE, COUNTY, AND DISTRICT FAIRS

(House Bill No. 1438. By Representatives Woodfin, Baer, Caywood, Datmeron, Farley, Fentress, Jackson, Lamb, MacFarlane, Monfort, and Schafer; also Senators Hobbs, Massari, and Taylor.)

### ANACT

#### AMENDING 54-1-16 (1), COLORADO REVISED STATUTES 1963 (1965 SUPP.), RELATING TO CONDUCTING HORSE RACE MEETS AT THE COLORADO STATE FAIR AND INDUSTRIAL EXPOSITION, FOR THE DURATION THEREOF, BUT NOT TO EXCEED NINE DAYS.

Be it enacted by the General Assembly of the State of Colorado:

Section 1. 54-1-16 (1), Colorado Revised Statutes 1963 (1965 Supp.), is amended to read:

54-1-16. Race meets — dates — licenses — fees. — (1) The Colorado STATE fair and industrial exposition commission is hereby authorized to obtain a license to conduct horse race meets at the Colorado state fair and industrial exposition pursuant to article 2 of chapter 129, C.R.S. 1963, AS AMENDED. provided, that For the purposes of this section the limitations in section 129-2-8, C.R.S. 1963, AS AMENDED, shall not apply, and such race meets shall be conducted on such dates not to exceed six days FOR THE DURATION OF THE SAID COLORADO STATE FAIR AND IN-DUSTRIAL EXPOSITION, BUT NOT TO EXCEED NINE DAYS, as may be set by the Colorado racing commission, except that no race meet shall be conducted on any Sunday.

Section 2. Safety clause.—The general assembly hereby finds, determines, and declares that this act is necessary for the immediate preservation of the public peace, health, and safety.

Capital letters indicate new material added to existing statutes; dashes through words indicate deletions from existing statutes and such material not part of act.
