(House Bill No. 1082. By Representative Mackie.)

A N A C T

AMENDING 105-3-14 (1), COLORADO REVISED STATUTES 1963, AND TO REPEAL 105-3-14 (2), COLORADO REVISED STATUTES 1963, CONCERNING THE HONOR WORK PROGRAM AT THE COLORADO STATE REFORMATORY.

Be it enacted by the General Assembly of the State of Colorado:

Section 1. 105-3-14 (1), Colorado Revised Statutes 1963, is amended to read:

105-3-14. Honor work program.—(1) Because the rapid increase of inmate population at the Colorado state reformatory, at Buena Vista, has created an emergency that must be given immediate attention, there ~~THERE~~ is hereby established an honor work camp program to provide employment for the inmates AT THE COLORADO STATE REFORMATORY, AT BUENA VISTA, and to increase the possibility for THEIR rehabilitation. The program shall be under the supervision of the director of institutions, and work projects undertaken shall be under his direction; ~~provided, that~~ BUT any work project proposed to be undertaken on any land under the jurisdiction of the state park and recreation board GAME, FISH, AND PARKS DEPARTMENT first shall be approved by THE GAME, FISH, AND PARKS COMMISSION. ~~said board~~

Section 2. Repeal.—105-3-14 (2), Colorado Revised Statutes 1963, is repealed.

Section 3. Safety clause.—The general assembly hereby finds, determines, and declares that this act is necessary for the immediate preservation of the public peace, health, and safety.

Capital letters indicate new material added to existing statutes; dashes through words indicate deletions from existing statutes and such material not part of act.
