OIL AND NATURAL GAS

(Senate Bill No. 163. By Senators Hewett, Bradley, Oliver, Garnsey, and Taylor; also Representatives Fowler and Gebhardt.)

A N A C T

AMENDING SECTION 100-2-25, COLORADO REVISED STATUTES 1963, CONCERNING SEALS ON METERS OR MECHANICAL DEVICES FOR THE MEASUREMENT OF OIL OR GASOLINE.

Be it enacted by the General Assembly of the State of Colorado:

Section 1. 100-2-25, Colorado Revised Statutes 1963, is amended to read:

100-2-25. Measuring device—sealing.—No person, or agent or employee of any person, shall use any meter or mechanical device for the measurement of oil or gasoline unless the same has been sealed as correct and the sealing approved by the state inspector of oils or one of his deputies in writing. THE STATE INSPECTOR OF OILS OR HIS DEPUTIES ARE FURTHER AUTHORIZED, IN THE EVENT ANY SUCH METER OR MECHANICAL DEVICE FAILS TO COMPLY WITH ANY OF THE PROVISIONS OF THIS ARTICLE, TO SEAL SUCH METER OR MECHANICAL DEVICE IN SUCH A MANNER AS TO PROHIBIT ITS USE UNTIL SUCH METER OR MECHANICAL DEVICE COMPLIES WITH ALL OF THE PROVISIONS OF THIS ARTICLE, AT WHICH TIME SAID SEAL SHALL BE REMOVED BY THE STATE INSPECTOR OF OILS OR HIS DEPUTIES. Any person, or agent or employee of any person, who shall change or in any way tamper with the ANY SUCH seal shall be subject to the penalties provided in section 100-2-28.

Section 2. Safety clause.—The general assembly hereby finds, determines, and declares that this act is necessary for the immediate preservation of the public peace, health, and safety.

Capital letters indicate new material added to existing statutes; dashes through words indicate deletions from existing statutes and such material not part of act.
