## CHAPTER 210

**INTOXICATING LIQUORS****FERMENTED MALT BEVERAGES**

(House Bill No. 1334. By Representatives Klein, Bastien, Black, Coffee, Farley, Gollob, Grove, Horst, Monfort, Norgren, Safran, Schubert, and Vanderhoof; also Senators Brown, Cisneros, Decker, and Williams.)

**A N A C T**

AMENDING 75-1-5 (1), COLORADO REVISED STATUTES 1963, AS AMENDED, PROVIDING FOR THE ISSUANCE OF LICENSES TO SELL FERMENTED MALT BEVERAGES FOR CONSUMPTION ON THE PREMISES, OR OFF THE PREMISES, OR BOTH.

*Be it enacted by the General Assembly of the State of Colorado:*

Section 1. 75-1-5 (1), Colorado Revised Statutes 1963, as amended, is amended BY THE ADDITION OF A NEW PARAGRAPH (e) to read:

75-1-5. **Qualifications and conditions for license.**—(1) (e) (i) The local licensing authority, based upon one of the following classifications specified in the application, shall restrict the use of said license to:

- (ii) Sales for consumption off the premises of the licensee; or
- (iii) Sales for consumption on the premises of the licensee; or
- (iv) Sales for consumption both on and off the premises of the licensee.

(v) The provisions of this paragraph (e) shall not apply to any license issued or applied for under this article prior to the effective date of this paragraph, nor to any renewal or reissuance thereof.

Section 2. **Effective date.**—This act shall take effect July 1, 1967.

Section 3. **Safety clause.**—The general assembly hereby finds, determines, and declares that this act is necessary for the immediate preservation of the public peace, health, and safety.
