## LIQUEFIED PETROLEUM GAS—REGULATIONS

(Senate Bill No. 170. By Senators Hewett, Bradley, Oliver, and Garnsey; also Representatives Fowler and Gebhardt.)

## A N A C T

AMENDING SECTION 100-5-5, COLORADO REVISED STATUTES 1963, RELATING TO MINIMUM STANDARDS FOR LIQUEFIED PETROLEUM GAS.

*Be it enacted by the General Assembly of the State of Colorado:*

Section 1. 100-5-5, Colorado Revised Statutes 1963, is amended to read:

100-5-5. **Minimum standards.**—The design, construction, location, installation, and operation of liquefied petroleum gas systems and equipment, and the transportation and handling of liquefied petroleum gas, and the odorization of liquefied petroleum gas, the degree thereof, and the odorizing agent to be used therein, shall conform to the minimum standards therefor as prescribed by pamphlet number 58, issued ~~May 1962~~ IN 1965, by the national fire protection association and by pamphlet number 54, issued ~~June 1959~~ IN 1964, 60 Batterymarch Street, Boston 10, Massachusetts. The minimum standards as prescribed in said pamphlets numbered 58 and 54 shall also apply to marine and pipeline terminals, natural gasoline plants, refineries, tank farms, underground storage facilities, such as salt and coal mines, aboveground storage facilities, and to chemical plants utilizing liquefied petroleum gas in the manufacture of their products. Copies of said pamphlets shall be kept and maintained in the office of the state inspector of oils at all times for examination by any interested person.

Section 2. **Safety clause.**—The general assembly hereby finds, determines, and declares that this act is necessary for the immediate preservation of the public peace, health, and safety.
