CHAPTER 322

GAME, FISH, AND PARKS**LICENSES AND FEES**

(House Bill No. 1353. By Representatives Schubert, Edmonds, Morris, Porter, and Wilder; also Senator Jackson.)

A N A C T

AMENDING 62-3-3 (3), AND 62-3-4 (1), COLORADO REVISED STATUTES 1963, AS AMENDED, CONCERNING GAME AND FISH, AND PROVIDING FOR HUNTING, FISHING, AND TRAPPER'S LICENSES, AND FEES THEREFOR.

Be it enacted by the General Assembly of the State of Colorado:

Section 1. 62-3-3 (3), Colorado Revised Statutes 1963, as amended, is REPEALED AND RE-ENACTED, WITH AMENDMENTS, to read:

62-3-3. Licenses—class—issuance.—(3) (a) Licenses pursuant to this article shall be as follows:

(b) Resident sportsman's license, which shall include deer, elk, fishing, small game, bear, and mountain lion; nonresident sportsman's licenses, which shall include deer, elk, fishing, small game, bear, and mountain lion.

(c) Resident elk license and nonresident elk license.

(d) Resident deer license and nonresident deer license.

(e) Resident antelope license and nonresident antelope license.

(f) Resident mountain lion license and nonresident mountain lion license.

(g) Resident bear license and nonresident bear license.

(h) Resident mountain sheep license.

(i) Resident mountain goat license.

(j) Resident buffalo license.

(k) Resident small game license and nonresident small game license.

(l) Resident turkey license and nonresident turkey license.

(m) Resident fishing license.

(n) Resident combination small game hunting and fishing license.

(o) Nonresident annual fishing license and nonresident ten-day license.

(p) Resident trapper's license and nonresident trapper's license.

(q) Licenses issued to convalescent men in military hospitals.

Section 2. 62-3-4 (1), Colorado Revised Statutes 1963, as amended, is REPEALED AND RE-ENACTED, WITH AMENDMENTS, to read:

62-3-4. Licenses—fees.—(1) (a) Licenses pursuant to this article and fees for licenses shall be as follows:

(b) Resident sportsman's license, thirty dollars, which shall include deer, elk, fishing, small game, bear, and mountain lion; nonresident sportsman's license, one hundred thirty-five dollars, which shall include deer, elk, fishing, small game, bear, and mountain lion.

(c) Resident elk license, twelve dollars and fifty cents; nonresident elk license, seventy-five dollars.

(d) Resident deer license, ten dollars; nonresident deer license, fifty dollars.

(e) Resident antelope license, ten dollars; nonresident antelope license, fifty dollars.

(f) Resident mountain lion license, twenty-five dollars; nonresident mountain lion license, fifty dollars.

(g) Resident bear license, five dollars; nonresident bear license, twenty-five dollars.

(h) Resident mountain sheep license, forty dollars.

(i) Resident mountain goat license, forty dollars.

(j) Resident buffalo license, two hundred dollars.

(k) Resident small game license, four dollars; nonresident small game license, fifteen dollars.

(l) Resident turkey license, five dollars; nonresident turkey license, ten dollars.

(m) Resident fishing license, six dollars.

(n) Resident combination small game hunting and fishing license, seven dollars and fifty cents.

(o) Nonresident annual fishing license, ten dollars.

(p) Nonresident ten-day fishing license, five dollars; purchaser may repurchase at expiration upon payment of said fee.

(q) Resident trapper's license, three dollars and fifty cents; nonresident trapper's license, twenty-five dollars.

(r) Convalescent men in military hospitals may be licensed pursuant to subsection (2) of this section.

Section 3. Effective date.—This act shall take effect July 1, 1967, except that licenses in effect on that date shall continue to be valid for the remainder of the term for which they were issued.

Section 4. Safety clause.—The general assembly hereby finds, determines, and declares that this act is necessary for the immediate preservation of the public peace, health, and safety.
