A N A C T

AMENDING CHAPTER 14, SESSION LAWS OF COLORADO 1966, AS AMENDED,
CONCERNING ROADSIDE ADVERTISING.

Be it enacted by the General Assembly of the State of Colorado:

Section 1. Section 6 of chapter 14, Session Laws of Colorado 1966, as amended by section 2 of chapter 299, Session Laws of Colorado 1967, is amended to read:

Section 6. **Expiration of act—suspension of other laws.**—This act shall be and remain in force and effect until July 1, 1968 1969, after the convening of the next regular session of the general assembly, and shall be null and void thereafter. All the provisions of sections 120-5-1 through 120-5-10, C.R.S. 1963 (1965 Supp.), which are inconsistent with this act shall be temporarily suspended for the duration of this act. **NOTHING CONTAINED IN THIS ACT, AS AMENDED, SHALL BE CONSTRUED TO TEMPORARILY SUSPEND ANY PROVISION OF SECTIONS 120-5-1 THROUGH 120-5-10, C.R.S. 1963, AS AMENDED, WHICH PROVISIONS ARE DESIGNED TO QUALIFY THE STATE FOR PAYMENTS MADE AVAILABLE TO THOSE STATES WHICH MEET FEDERAL STANDARDS OF ROADSIDE ADVERTISING CONTROL ALONG THE INTERSTATE HIGHWAYS.** Upon the expiration of this act, however, all such provisions shall again become of full force and effect unless repealed or amended by the general assembly prior to said date.

Section 2. **Repeal.**—Section 2 (1) (f) of chapter 14, Session Laws of Colorado 1966, as added by section 1 of chapter 299, Session Laws of Colorado 1967, is repealed.

Section 3. **Safety clause.**—The general assembly hereby finds, determines, and declares that this act is necessary for the immediate preservation of the public peace, health, and safety.

Capital letters indicate new material added to existing statutes; dashes through words indicate deletions from existing statutes and such material not part of act.
