COUNTY PUBLIC IMPROVEMENT DISTRICT ACT

[Tentative placement, 36-25-3 et seq.]

(House Bill No. 1432. By Representatives Fuhr, Dittmore, Moore, and Cole; also Senator H. Fowler.)

A N A C T

AMENDING THE "COUNTY PUBLIC IMPROVEMENT DISTRICT ACT OF 1968".

Be it enacted by the General Assembly of the State of Colorado:

Section 1. Section 3 (2) of chapter 58, Session Laws of Colorado 1968, is amended to read:

Section 3. **Definitions.**—(2) "Improvement district", hereinafter referred to as a "district", means a taxing unit which may be created within any county in this state, whether operating under a home rule charter or under the general laws of the state, for the purpose of constructing, or installing, OR OTHERWISE ACQUIRING therein any public improvement, including, but not limited to, grading, paving, curbing, guttering, or otherwise improving the whole or any part of any street or alley, parking and off-street parking facilities, sewer drainage collection systems, storm sewer drainage systems, surface drainage systems, but excepting electric light or gas systems or plants, water and sewer treatment systems, facilities, and distribution lines. No such improvement or facility shall duplicate or interfere with any improvement already constructed within the limits of such district.

Section 2. Section 5 (2) (c) of chapter 58, Session Laws of Colorado 1968, is amended to read:

Section 5. **Organization petition—contents.**—(2) (c) A general description of the improvements to be constructed, or installed, OR OTHERWISE ACQUIRED within and for the district;

Section 3. **Effective date.**—This act shall take effect July 1, 1969.

Section 4. **Safety clause.**—The general assembly hereby finds, determines, and declares that this act is necessary for the immediate preservation of the public peace, health, and safety.

Capital letters indicate new material added to existing statutes; dashes through words indicate deletions from existing statutes and such material not part of act.
