#### CHAPTER 303

### SCHOOLS II — STATE UNIVERSITIES, COLLEGES, AND ACADEMIES

#### COLORADO GENERAL HOSPITAL

(House Bill No. 1272. By Representatives Schmidt, Arnold, Grant, Fuhr, Shore, and Showalter; also Senators L. Fowler and Chance.)

## ANACT

#### AMENDING 124-4-6 (2), COLORADO REVISED STATUTES 1963, CONCERNING HOSPITAL ADMISSIONS, CHARGES, AND FEES.

Be it enacted by the General Assembly of the State of Colorado:

Section 1. 124-4-6 (2), Colorado Revised Statutes 1963, is amended to read:

124-4-6. Hospital admissions—charges—fees.—(2) Students of the university and such other patients as the board of regents, to an extent that will not interfere with the primary purpose of said hospital as set forth in section 124-4-3, may direct, may be received in said hospital whenever there is room. In addition to charges for hospital care, such students and other patients may be charged fees for professional services rendered to them by physicians, er surgeons, OR DENTISTS who are members of the medical staff of the hospital. Any such charges for professional services shall be made by the physicians, er surgeons, OR DENTISTS rendering the service but shall be collected through the medium of the hospital and upon collection shall be placed in a fund to be established, maintained, and used solely for the payment of compensation to members of the faculty of the school of medicine AND SCHOOL OF DENTISTRY, all in accordance with rules to be adopted by the board of regents.

Section 2. Safety clause.—The general assembly hereby finds, determines, and declares that this act is necessary for the immediate preservation of the public peace, health, and safety.

Capital letters indicate new material added to existing statutes; dashes through words -indicate deletions from existing statutes and such material not part of act.
