## CHAPTER 369

## VOCATIONAL EDUCATION

## PROPRIETARY SCHOOLS

(House Bill No. 1185. By Representatives Cole and Safran ; also Senator Decker.)

## A N A C T

AMENDING 146-3-9 (5) AND 146-3-11 (2), COLORADO REVISED STATUTES 1963, AS AMENDED, TO REVISE AND CORRECT LAWS CONCERNING PROPRIETARY SCHOOLS.

*Be it enacted by the General Assembly of the State of Colorado:*

Section 1. 146-3-9 (5), Colorado Revised Statutes 1963 (1967 Supp.), is amended to read:

**146-3-9. Accreditation.**—(5) In compliance with subsections (1), (2), (3), and (4) of this section, the state board for vocational education shall have the authority to recognize as being accredited for purposes of this article, and to issue thereto a certificate of accreditation, a school which has been accredited by a nationally recognized accrediting agency or association, qualified to accredit schools of a particular category, which has been so designated by the commissioner of education of the United States office of education.

Section 2. 146-3-11 (2), Colorado Revised Statutes 1963 (1967 Supp.), is amended to read:

**146-3-11. Advisory committee.**—(2) (a) Within thirty days after the effective date of this article MARCH 3, 1966, the above named advisory board shall be appointed by a two-thirds vote of the state board for vocational education. The chief executive officer of the department of vocational education **DIRECTOR OF OCCUPATIONAL EDUCATION** shall recommend persons for appointment to the state board.

(b) Terms of office shall be for three years with initial appointments to be divided so that one-third of the members shall serve one, two, and three years respectively. As the term of office of each member shall expire, a successor shall be appointed by a two-thirds vote of the state board for vocational education for a term of three years.

Section 3. **Safety clause.**—The general assembly hereby finds, determines, and declares that this act is necessary for the immediate preservation of the public peace, health, and safety.
