(Senate Bill No. 266. By Senator Jackson; also Representative Black.)

**A N A C T**

AMENDING 88-6-2, COLORADO REVISED STATUTES 1963, AS AMENDED, CONCERNING THE "COLORADO LOCAL GOVERNMENT AUDIT LAW", AND DEFINING THE TERM "LOCAL GOVERNMENT".

*Be it enacted by the General Assembly of the State of Colorado:*

Section 1. 88-6-2 (1) (e), Colorado Revised Statutes 1963 (1965 Supp.), is amended, to read:

88-6-2. **Definitions.**—(1) (e) A local improvement and service district, special district, or any other governmental unit having the authority under the general laws of this state to tax or impose assessments, INCLUDING SPECIAL ASSESSMENTS.

Section 2. 88-6-2 (1), Colorado Revised Statutes 1963 (1965 Supp.), is amended BY THE ADDITION OF A NEW PARAGRAPH to read:

88-6-2. **Definitions.**—(1) (f) Any organization of political subdivisions of the state, or their officers or employees, the expenses of which are paid in whole or in part from dues or contributions received from its member political subdivisions.

Section 3. **Effective date—applicability.**—This act shall take effect on July 1, 1969, and shall apply to all audits performed and required to be performed on and after such date.

Section 4. **Safety clause.**—The general assembly hereby finds, determines, and declares that this act is necessary for the immediate preservation of the public peace, health, and safety.
