AMENDING 142-2-19, COLORADO REVISED STATUTES 1963, AS AMENDED, CONCERNING INSPECTION FEES CHARGED BY ELECTRICIANS.

Be it enacted by the General Assembly of the State of Colorado:

Section 1. 142-2-19 (1) (c), Colorado Revised Statutes 1963 (1965 Supp.), is amended, and the said 142-2-19 (1) is further amended BY THE ADDITION OF A NEW PARAGRAPH, to read:

142-2-19. Inspection fees. (1) (c) All other fees, EXCEPT FOR INSPECTIONS IN MOBILE HOMES AND TRAVEL TRAILER PARKS, shall be computed on the dollar value of the electrical installation, including fixtures and installation costs thereof, AND SUCH FEES SHALL BE as follows:

Valuation of work	Fee
Not more than \$50.00	\$ 4.00
More than \$50.00 but Not more than \$300.00	5.00 6.00
More than \$300.00 but not more than \$2,000.00	8.00
More than \$2,000.00 but not more than \$50,000.00	\$4.00 per each \$1,000.00 valuation or fraction thereof
More than \$50,000.00 but not more than \$500,000.00	\$50.00 plus \$3.00 per each \$1,000.00 valuation or fraction thereof of total valuation
More than \$500,000.00	\$550.00 plus \$2.00 per each \$1,000.00 valuation or fraction thereof of total valuation
MOBILE HOMES AND TRAVEL TRAILER PARKS, PER SPACE	5.00

Capital letters indicate new material added to existing statutes; dashes through words indicate deletions from existing statutes and such material not part of act.

(d) In the event that an application for inspection is not filed in advance of the commencement of an installation, or prior to the sale of any new mobile home, travel trailer, modular home, or camper, as required by section 142-2-17 (2), the inspection fee shall be twice the amount prescribed therefor in this section.

Section 2. Effective date. This act shall take effect July 1, 1971.

Section 3. Safety clause. The general assembly hereby finds, determines, and declares that this act is necessary for the immediate preservation of the public peace, health, and safety.
