A N A C T

AMENDING 123-30-10 (6), COLORADO REVISED STATUTES 1963, AS AMENDED, CONCERNING POWER OF SCHOOL BOARDS TO SELL AND CONVEY DISTRICT PROPERTY.

Be it enacted by the General Assembly of the State of Colorado:

Section 1. 123-30-10 (6), Colorado Revised Statutes 1963 (1965 Supp.), is amended to read:

123-30-10. Board of education — specific powers. (6) To sell and convey district property which may not be needed within the foreseeable future for any purpose authorized by law, upon such terms and conditions as it may approve; and to lease any such property, pending sale thereof, under an agreement of lease, with or without an option to purchase the same. **NO FINDING THAT THE PROPERTY MAY NOT BE NEEDED WITHIN THE FORESEEABLE FUTURE SHALL BE NECESSARY IF THE PROPERTY IS SOLD AND CONVEYED TO A STATE AGENCY OR POLITICAL SUBDIVISION OF THIS STATE.**

Section 2. **Safety clause.** The general assembly hereby finds, determines, and declares that this act is necessary for the immediate preservation of the public peace, health, and safety.
