## LABOR

WORKMEN'S COMPENSATION—AVERAGE WEEKLY  
WAGE OF MINOR

(House Bill No. 568. By Representatives Lewis, Brooks and Comings)

## AN ACT

AMENDING SUB-SECTION (d) OF SECTION 5 OF AN ACT  
ENTITLED "AN ACT CONCERNING WORKMEN'S  
COMPENSATION AND AMENDING SECTION 2, CHAP-  
TER 186, SESSION LAWS OF 1929."

*Be It Enacted by the General Assembly of the State of Colorado:*

Section 1. Subsection (d) of Section 5 of an Act entitled "An Act concerning Workmen's Compensation and amending Section 2, Chapter 186, Session Laws of 1929", the same being Chapter 275 of the Session Laws of Colorado, 1937, is hereby amended to read as follows:

"(d) Where an employee is a minor and the disability is temporary the average weekly wage of such minor shall be determined by the Commission as in cases of disability of adults. Where the disability of such minor is permanent or if benefits under this Act shall accrue because of the death of such minor, compensation to said minor or death benefits to his dependents shall be paid at the maximum rate of compensation payable under this Act at the time of the determination of such permanency or of such death."

Section 2. All Acts and parts of Acts in conflict with this Act are hereby repealed.

Section 3. The General Assembly hereby finds, determines and declares that this Act is necessary for the immediate preservation of the public peace, health and safety.

Section 4. In the opinion of the General Assembly an emergency exists therefore, this Act shall take effect and be in force from and after its passage.
