## PUBLIC SCHOOL FOUNDATION ACT OF 1969

## AN ACT

AMENDING 123-38-9 (3), COLORADO REVISED STATUTES 1963, AS AMENDED, CONCERNING THE EQUALIZATION LEVEL OF SUPPORT UNDER THE PUBLIC SCHOOL FOUNDATION ACT OF 1969.

*Be it enacted by the General Assembly of the State of Colorado:*

Section 1. 123-38-9 (3), Colorado Revised Statutes 1963 (1969 Supp.), is amended to read:

**123-38-9. State equalization program.** (3) For the calendar year 1970 1973, the equalization level of support shall be four hundred forty FIVE HUNDRED EIGHTEEN dollars per pupil of average daily attendance entitlement of the school district, ~~for the calendar year 1974, the equalization level of support shall be four hundred sixty dollars per pupil of average daily attendance entitlement of the school district;~~ and the general assembly shall review the equalization level of support annually thereafter.

Section 2. **Appropriation.** In addition to any other appropriation made for the fiscal year beginning July 1, 1972, there is hereby appropriated out of any moneys in the state treasury not otherwise appropriated, to the department of education, the sum of sixteen million thirty-two thousand three hundred five dollars (\$16,032,305), or so much thereof as may be necessary, for the purpose of increasing the state equalization program as provided in section 123-38-9 (3), C.R.S. 1963, as amended by section 1 of this act.

Section 3. **Safety clause.** The general assembly hereby finds, determines, and declares that this act is necessary for the immediate preservation of the public peace, health, and safety.
