CHAPTER 262

INTOXICATING LIQUORS

LIQUOR CODE OF 1935

HOUSE BILL, NO. 1489. BY REPRESENTATIVES Gustafson and Pettie: also SENATORS Calabrese and Garnsey.

AN ACT

AMENDING 75-2-3, COLORADO REVISED STATUTES 1963, CONCERNING UNLAWFUL ACTS OF ANY PERSON REQUIRED TO BE LICENSED AS A MANUFACTURER OR IMPORTER OF VINOUS AND SPIRITUOUS LIQUORS.

Be it enacted by the General Assembly of the State of Colorado:

- Section 1. 75-2-3, Colorado Revised Statutes 1963, as amended, is amended BY THE ADDITION OF A NEW SUBSECTION to read:
- 75-2-3. Unlawful acts. (24) Unless determined by the director, in his discretion, as not constituting unfair competition or unfair practice, it is unlawful for any person, as a manufacturer or importer, to import or sell any vinous or spirituous liquor in this state unless the manufacturer or importer of such liquor is the primary source of supply in the United States for the brand of such liquor to be imported or sold and unless such person holds a valid manufacturer's or importer's license issued under the provisions of section 75-2-17.
- Section 2. Effective date repeal. This act shall take effect upon its passage, and shall be repealed on July 1, 1975.
- Section 3. Salety clause. The general assembly hereby finds, determines, and declares that this act is necessary for the immediate preservation of the public peace, health, and safety.
