## LICENSE CERTIFICATES — OPTOMETRISTS

## AN ACT

AMENDING 102-1-13 (2), COLORADO REVISED STATUTES 1963, RELATING TO  
DUPLICATE LICENSE CERTIFICATES FOR OPTOMETRISTS.

*Be it enacted by the General Assembly of the State of Colorado:*

Section 1. 102-1-13 (2), Colorado Revised Statutes 1963, is amended to read:

**102-1-13. Change of address, duplicate license certificates.** (2) Any licensee may maintain offices which he periodically visits, other than that in which he maintains and carries on his principal practice, and a duplicate license certificate shall be issued for each such additional office upon application to the board upon forms provided for such purpose and upon payment of a fee in the amount of five TEN dollars.

Section 2. **Safety clause.** The general assembly hereby finds, determines, and declares that this act is necessary for the immediate preservation of the public peace, health, and safety.
