#### CHAPTER 62

### AUTOMOBILES AND OTHER MOTOR VEHICLES

REGISTRATION AND SPECIFIC OWNERSHIP TAX, TON MILE TAX, PASSENGER MILE TAX

HOUSE BILL. NO. 1260. BY REPRESENTATIVES O'Brian, Showalter, Bryant, Bucchner, Eaker, Eckelberry, Gunn, Hamlin, Herzberger, Miller, Hayes, and Koster; also SENATORS Johnson and Minister.

## AN ACT

AMENDING 13-3-14 (3), COLORADO REVISED STATUTES 1963, AS AMENDED, TO INCREASE THE REGISTRATION FEE FOR TEMPORARY REGISTRATION NUMBER PLATES, TAGS, OR CERTIFICATES.

Be it enacted by the General Assembly of the State of Colorado:

Section 1. 13-3-14 (3), Colorado Revised Statutes 1963 (1969 Supp.), is amended to read:

- 13-3-14. Expiration temporary, new, and old plates reflectorized plates. (3) (a) The department is authorized to issue INDIVIDUAL temporary registration number plates, tags, or a certificate good for a period of not to exceed twenty THIRTY days upon the filing of application by any owner or his agent, dealer, salesman, or chauffeur and the payment of a registration fee of fifty cents, one-half ONE DOLLAR AND TWENTY-FIVE CENTS, ONE DOLLAR thereof to be retained by the county clerk issuing the plates, tags, or certificates and the remainder to be remitted monthly to the department of revenue to be deposited with the state treasurer to the credit of the highway users tax fund. It shall be unlawful for any person to make use of such number plate, tag, or certificate after the expiration of the period for which the same was issued.
- (b) THE DEPARTMENT IS FURTHER AUTHORIZED TO ISSUE TO LICENSED MOTOR VEHICLE DEALERS TEMPORARY REGISTRATION NUMBER PLATES, TAGS, OR CERTIFICATES IN BLOCKS OF TWENTY-FIVE UPON PAYMENT OF A FEE OF TWELVE DOLLARS AND FIFTY CENTS FOR EACH BLOCK OF TWENTY-FIVE, FIFTY PERCENT THEREOF TO BE RETAINED BY THE COUNTY CLERK ND THE REMAINDER TO BE REMITTED MONTHLY TO THE DEPARTMENT OF REVENUE TO BE DEPOSITED WITH THE STATE TREASURER TO THE CREDIT OF THE highwG8 USERS TAX FUND.

Section 2. Effective date. This act shall take effect July 1, 1973.

Section 3. Safety clause. The general assembly hereby finds, determines, and declares that this act is necessary for the immediate preservation of the public peace, health, and safety.
