CHAPTER 185

WILDLIFE AND PARKS AND OUTDOOR RECREATION

GENERAL PROVISIONS — ADMINISTRATION

SENATE BILL NO. 356. BY SENATORS Birmingham, G. Brown, Darby, Jackson, and Johnson; also REPRESENTATIVES Herzberger, Spano, and Strang.

AN ACT

AMENDING 62-1-8 (1), COLORADO REVISED STATUTES 1963, AS AMENDED, RELATING TO THE PUBLIC NOTICE OF THE RULES AND REGULATIONS PROMULGATED BY THE WILDLIFE COMMISSION.

Be it enacted by the General Assembly of the State of Colorado:

Section 1. 62-1-8 (1), Colorado Revised Statutes 1963 (1969 Supp.), is amended to read:

62-1-8. Rules and regulations — procedure — judicial notice. (1) NOTICE OF rules and regulations of PROMULGATED BY the commission shall be published at least once in ~~some newspaper~~ TWO NEWSPAPERS IN EACH COMMISSIONER DISTRICT published in and having general circulation throughout the state. SUCH NOTICE SHALL INCLUDE A STATEMENT THAT COPIES OF THE RULES AND REGULATIONS ARE AVAILABLE AT THE OFFICE OF THE DIVISION OF WILDLIFE. NOTICE OF such rules and regulations may also be given such other publicity as the commission may deem desirable. Such publication shall fix the date such rules and regulations become effective, which, unless an emergency or temporary rule or regulation is enacted, shall not be less than ~~two days after publication~~ TEN DAYS AFTER THEY HAVE BEEN FILED WITH THE SECRETARY OF STATE, notwithstanding the provisions of section 3-16-2 (5), C.R.S. 1963, as amended.

Section 2. **Effective date.** This act shall take effect July 1, 1973.

Section 3. **Safety clause.** The general assembly hereby finds, determines, and declares that this act is necessary for the immediate preservation of the public peace, health, and safety.

Capital letters indicate new material added to existing statutes; dashes through words indicate deletions from existing statutes and such material not part of act.
