INSURANCE

NONPROFIT HOSPITAL, MEDICAL-SURGICAL,
AND HEALTH SERVICE CORPORATIONS

AN ACT

AMENDING 72-24-14, COLORADO REVISED STATUTES 1963, CONCERNING CERTAIN
HEALTH SERVICE BENEFITS.

Be it enacted by the General Assembly of the State of Colorado:

Section 1. 72-24-14, Colorado Revised Statutes 1963 (1967 Supp.), is amended to read:

72-24-14. Scope of benefits. The benefits or services which a corporation subject to the provisions of this article may ~~contract to make available to~~ its members or subscribers shall ~~MAY~~ include ~~all of the services made available by hospitals, or other licensed health care institutions, doctors of medicine, osteopathy, dentistry, OPTOMETRY and podiatry, nursing services, appliances, drugs, medicine, ambulance service, and such other health services or items as the board of trustees of any such corporation may approve; but no corporation subject to the provisions of this article may offer to its members or subscribers any certificate or form which would provide for a cash payment or allowance for sickness, accident, disability, or death, other than payments of or toward the charges made by the purveyors of the health services covered by the certificates issued by said corporation, or for any form of casualty or life insurance unless such corporation shall first comply with the statutes of this state applicable to companies offering such forms of insurance.~~

Section 2. Safety clause. The general assembly hereby finds, determines, and declares that this act is necessary for the immediate preservation of the public peace, health, and safety.

Capital letters indicate new material added to existing statutes; dashes through words indicate deletions from existing statutes and such material not part of act.
