CHAPTER 104

HIGHER EDUCATION AND VOCATIONAL TRAINING

STATE ASSISTANCE FOR VOCATIONAL EDUCATION

HOUSE BILL NO. 1039. AN ACT

AMENDING 23-8-102 (1) (b), COLORADO REVISED STATUTES 1973, CONCERNING THE STATE'S SHARE OF VOCATIONAL EDUCATION PROGRAM SUPPORT.

Be it enacted by the General Assembly of the State of Colorado:

Section 1. 23-8-102 (1) (b), Colorado Revised Statutes 1973, is **REPEALED AND REENACTED, WITH AMENDMENTS**, to read:

23-8-102. School districts conducting vocational education courses — eligibility for state funds. (1) (b) As vocational education program support, the state shall provide, to each school district conducting an approved vocational education program for each twelve-month period beginning July 1, eighty percent of the first one thousand two hundred fifty dollars, or part thereof, by which the district's approved vocational education program cost per full-time equivalent student exceeds seventy percent of the district's authorized revenue base for the school budget year during which such twelve-month period begins. In addition, if the district's approved vocational education cost per full-time equivalent student exceeds seventy percent of its authorized revenue base by an additional amount in excess of one thousand two hundred fifty dollars, the state shall provide fifty percent of such additional amount.

Section 2. **Effective date.** This act shall take effect July 1, 1976.

Section 3. **Safety clause.** The general assembly hereby finds, determines, and declares that this act is necessary for the immediate preservation of the public peace, health, and safety.

Capital letters indicate new material added to existing statutes; dashes through words indicate deletions from existing statutes and such material not part of act.
